Small ruminants (especially goats) contribute to the livelihoods of millions of rural poor in most of the developing countries of Asia and Africa, where 95% of the world's goat population is concentrated and also the majority of world's poor live. Goats offer opportunities for development interventions including micro credit, extension services, technical and marketing support especially to women, landless, and small farmers. Goats are especially suitable for landless and small-holder farmers who for variety of reasons cannot maintain large ruminants like cow and buffaloes. Small ruminants are well integrated in the farming systems of the small and marginal farmers of India who find in goats a vast potential for their socio-economic upliftment.

We humbly request to forward/nominate senior level team leaders/Heads from your organization/CSR to participate and contribute to the workshop. Filled in registration form should reach us at least **5 days before date of** workshop along with requisite fees. We will confirm your participation and venue details within a week of receiving it.

It is highly appreciated, if you nominate the NGOs those are working for development of women, poor and marginalized community in your respective area so that they could participate and learn about the small livestock based livelihood promotion of the target families/communities.

The nominal participation fee will be INR 1000/- per participants which includes workshop materials and working lunch, tea & snacks.
